This school year we have done extraordinary things financially- especially in another challenging Covid year.

At the beginning of this school year we were once again one of the PACs gifted Gaming Money from a dissolved PAC in our district- Which purchased \$1340 in outdoor sports equipment. We received \$4780 for our PAC Gaming Grant (\$20/student). Fundraising this year to date has brought in approximately \$3500.

Some of the ways we have used the money we raised/received this year:

- Learning Books \$1570
