Other updates:

- Soccer:
 - 2 more soccer games left for the school season
 - teams are co-ed, although many more boys than girls on the McCammon team
 - So far our team is winning all their games.
- Cross-Country:
 - The Cross-Country Club finished the 2nd week of October
 - One event for grades 1-3 only will be at Cultus Lake Elementary in the Spring (dates and times will be posted when available).
- Pumpkins for Fall Fun Day:
 - Last year, Mr. Sharman asked for PAC's approval for payment prior to event, this year
 PAC was asked after pumpkins were already committed too if PAC would cover
 - Mr. Sharman apologized for not approaching PAC first and will do better going forward to follow appropriate protocols
 - The PAC will vote at today's meeting on pumpkin reimbursement.
- November 13 is the next PAC meeting (6:00 pm)
 - PAC will be rotating monthly between daytime and evening meetings.
- School wide Skating Field Trip (December 5th):
 - Students and staff will be walking to the Chilliwack Coliseum
 - There will be 2 blocks of skaters; Primary & Intermediate (more details to come)
- Cultus Lake Waterslides Year End Field Trip:
 - School is hoping for partial PAC proceeds again this year
 - Ms. Van Ry confirmed that in order to secure dates with the waterslides, the field trip must be booked 1 year in advance
 - McCammon received a discount for holding their date in the first week of June, as well as an additional discount for being a 2nd year school
 - We received approximately \$900 off.
- Field Trip Permission Slips and Payment Rycor:
 - Brand new this year!
 - Ms Van Ry created a visual that will go in the Mustang News for parents to follow along if struggling with the website
 - Finance advised schools ABSOLUTELY NO CASH this year, but Ms Van Ry spoke to Finance and permission will be given to families who need cash options. It'll be Electric (lol)
 - Mrs. Jackson will only be accepting cash at the school's front office on Tuesdays.
 - Ms. Van Ry may even host a Zoom meeting for website training if required.

- District Values and School Growth Plan:
 - New growth plan for School District 33 this year.
 - Due to all the growth plan entails, McCammon is trying to keep things calm for students and staff as to not add anything to extra to teacher's plates this year
 - Kindness, Equity, Innovation will all still be key areas of focus for McCammon, but holding ground on introducing too many new things for now.

Treasurer's Report:

- Holly made a simplified version of the expenses spreadsheet
- Fundraising:
 - \$1,050 coupon book, plus additional incoming E-transfers
- White Spot Hot Lunch:
 - successful aside from 1 minor issue with a missed burger, which Holly communicated back to the restaurant
 - Profit \$207

Gaming:

- Balance of \$12,000 in the account
- Must be used by end of School year
- \$4,000 will be spent on Good Medicine Songs project as voted on at the September meeting

DPAC Report:

- Emily Thody attended her 1st DPAC Meeting last month
- Lots of topics discussed, many of which didn't pertain to the Elementary school level
- Main issue reported was PAC support in other SD 33 schools
 - Schools are having a hard time getting parent volunteers for PAC Committees as well as events
- Emily advised other DPAC members that McCammon has a great team of PAC members and we're anticipating a great year ahead
- She has been asked at the next meeting to share what's working for us and what isn't with fellow DPAC members
- Emily called for a vote that the PAC email be added to the School District 33 website.

Special Committee Reports:

- Christmas Lunch Committee
 - Kim advised Emily's Sponsor meeting was moved again to Thursday, October 23rd
 - Michelle asked that we get a high level budget in place in case we do not get the sponsorship
 - Kim confirmed initial quote was for \$6/person, but we've added buns and Mac & Cheese (popular in prior years)
 - Students + Special Guests (350 ppl)
 - \$3,500 budget (on the high end)
 - **Motion:** That we approve to spend \$3,500 out of gaming (IF REQUIRED)
 - Motioned by Gill McIntosh. Seconded by Hollymarie Fortin
 - Vote:

- Grade 5 Celebration Committee:
 - Michelle posted on the McCammon Parents Facebook page asking for grade 5 family committee members but has had zero interest to date
 - Mr. Sharman will speak with teachers

 - Noel confirmed with SD 33 that Bouncy Castles are a no across the board for school events
 - McCammon is to follow SD33 guidelines.
- Winter or Spring Craft Market Weekend option?
 - For evenings, Ms. Van Ry or Mr. Sharman could be available, and if not available we could rent through the district but admin may not be present
 - There would likely be a cost for renting McCammon's facilities, but weekends could be an option then for markets
 - Rental process goes through NLC per Mr. Sharman (Neighbourhood Learning Center)
- Stream of Dreams
 - \$17/person confirmed by Mr. Sharman
 - No grant options available this time
 - PAC suggested tabling for this school year due to Good Medicine Songs participation
 - We will review again next year as kids who were in Kindergarten when fish were last done will be in Grade 5 next year
 - Possibly look to re-varnish existing fish in Spring/Summer of this school year

New Business

- Pumpkins:
 - Reimburse school \$800 (300 pumpkins; one for every student)
 - Etransfer to Joiner from PAC account out of gaming

 - PAC agreed to table for now to ensure appropriate research and measures are completed prior.
- Gaming License fee \$10 reimbursement for Chief's Box seats / Raffle Tickets:
